



## AFFECT DESTINY TEAMS IMPACT 2009 Group Application & Stipulations\*

\*This signed application constitutes a letter of agreement between Reach the Children Foundation, Inc., d/b/a Book of Hope and Affect Destiny Teams and the participating group/church concerning the following stipulations.

### **Book of Hope International's Affect Destiny Teams (hereafter BOH) will:**

1. Provide all ground transportation, lodging, and meals within the ministry country. For teams going to remote areas requiring additional airfare in the ministry country (and thus paying a higher trip price), BOH will provide airfare in-country.
2. Provide necessary country admission and exit services for the ministry country, such as entrance visas and exit fees. Citizens of countries other than the United States are responsible to obtain their own visas, if required, for the ministry country. A photocopy of each visa must be sent to the BOH office.
3. Provide language translation services as needed for the team to minister effectively.
4. Provide all necessary ministry materials at the designated mission field.
5. Provide all pertinent trip information, including a team leader manual.

### **Participating group/church will:**

1. Submit this completed application with a \$300 non-refundable deposit no later than 120 days prior to the scheduled team departure date.
2. Submit a \$275 non-refundable deposit per team member by the first deadline at 90 days prior to the scheduled team departure date for all anticipated team members, along with a team member name list.
3. Submit a 50% payment of the balance of the remaining team payment by the second deadline at 60 days prior to the scheduled team departure date for all team members, along with the following: final name list; clear photocopies of the first two pages of each signed Passport OR physical Passport IF required for visa paperwork; the completed and signed Assumption of Risk form for adults OR the notarized Parental Consent form for minors under the age of 18 years at the date of departure; all documents required for the visa application if applicable; visa photocopies (for citizens of countries other than the U.S); and individual team member's email address and mailing address for further correspondence regarding trip details. All team members ages 18 and older must submit their social security number for mandatory background checks.
4. Submit the remaining trip payment balance by the third deadline at 30 days prior to the scheduled team departure date for all team members.
5. Submit payment for all penalties incurred by their team members (the penalties are outlined below at 30 days prior to the scheduled team departure date.
6. Note: TEAMS MAY NOT PURCHASE OR BOOK AIRLINE TICKETS UNTIL BOH CONFIRMS THE DESTINATION IN WRITING. BOH WILL CONFIRM THE TRIP DESTINATION NO LATER THAN 120 DAYS PRIOR TO DEPARTURE.

### **Penalties & Incentives:**

Penalties: The following penalties are instituted to encourage good stewardship of the resources God has given us. Any penalty assessed to your team is used to offset the additional expenses incurred by BOH in failing to meet the deadlines of our vendors. The penalties are as follows (all monies are in USD):

### **Late Submissions:**

1. 60-day deadline: a 2% penalty may be assessed for each team member who fails to submit the 60-day trip payment and all necessary forms by this deadline.
2. 30-day deadline: a 2% penalty may be assessed for each team member who fails to submit the 30-day trip payment and all necessary forms by this deadline.

### **Cancellations:**

1. All cancellations after 90 days will be refunded team funds minus the \$275 nonrefundable deposit and any visa fees.
2. Exceptions: Those who cancel due to emergencies will be considered on a case-by-case basis.

### **Incentives:**

For teams with 30 or more team members at the time of departure, BOH will cover one (1) leader's field costs. Further financial incentives occur for each additional 15 team members over 30.

**Note: BOH reserves the right to cancel, reschedule, or change itineraries based on certain circumstances (such as, but not limited to: war, acts of God, country instability, famine, disease, etc.)**

Only those authorized to act on behalf of the designated group and the sponsoring church or organization are permitted to complete this application. It also represents agreement with the following statement of faith and an intention to support the future development of ministry in the host country through submission to the instructions of BOH field personnel in matters of conduct and ministry practice.

**Statement of Faith**

1. We believe the Bible to be the inspired and the only infallible, authoritative Word of God.
2. We believe that there is one God, eternally existent in three persons: Father, Son, and Holy Spirit.
3. We believe in the deity of Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, in His present rule as Head of the Church, and in His personal return in power and glory.
4. We believe that for the salvation of lost and sinful men, regeneration by the Holy Spirit is absolutely essential.
5. We believe in the present ministry of the Holy Spirit, by whose indwelling the Christian is enabled to live a godly life.
6. We believe in the resurrection of both the saved and the lost: that the saved are saved unto the resurrection of life, and that the lost are lost unto the resurrection of damnation.
